1. <u>Call to Order:</u> President Ramirez called the meeting to order at 5:30 P.M. Those in attendance in addition to Ramirez were trustees Beth Blahut, Shelly Truttmann, Kelly Ruschman, Joanne Landry, Tiffany Kuenzi; Library Director Amy Trumble; and Village Liaison Larry Stuessy. Also present: Mary Anne Omichen; Village Clerk Kelsey Jenson; Village Board trustees Jesse Donahue, Jaime Craig and Gof Thomson.

2. Announcement:

A. The Library Board will convene into closed session called under WI State Statue 19.85(1)(e) Deliberating or negotiating the purchasing of public properties, the investing of public funds, or conducting other specified public business, whenever competitive or bargaining reasons require a closed session. (Deliberating the purchase of public property)

Kelsey Jenson discouraged the Library Board from including election venue assistance to the Town of New Glarus in the offer to purchase the Town Hall. She stated that it is the responsibility of the Town Clerk to secure a location for their elections and it would be inappropriate for the Library Board and/or Village Board to have a hand in that process. Jaime Craig stated that the Village Board supports the Library Board's plan to focus on securing the Town Hall site. She suggested tabling the Zwingli House conversation for now and perhaps revisiting it if we do not get the grant.
